PUBLIC MEETING MINUTES BALDWIN HILLS CONSERVANCY Friday, May 29, 2015

Call to Order

A public me eting of the Baldwi n Hills Conservancy (BHC) was assembled at 10:00 a.m. on Frid ay, May 29, 2015, at the Kenneth Hahn State Recreation Area Community Center, located at 4100 South La Cienega Boulevard, Los Angeles, CA 90056.

I. Roll Call

Members Present: Julie Alvis, Sara Amir, Allan Boodnick, Lloyd Dixon, Karen Finn, Russ Guiney, Robert Jones, Karly Katona, Jason Marshall, Craig Sap, Ana Straabe, Marina Voskanian, **Staff Present:** David McNeill, Executive Officer; Gail Krippner, Grant Program Manager; Avril LaBelle, Executive Secretary, Christina Bull-Arndt, Supervising Deputy Attorney General.

(After roll call, Chair Amir introduced special guest speaker - The Honorable Sebastian Ridley-Thomas, Assembly Member - 54th District.) Assembly Member Ridley-Thomas addressed the Board with information on AB446 and AB755. He stressed the importance of the BHC, and emphasized the need for green space and how it provides cost savings to the State of California. He pointed out that having green space stimulates local economic activity creating benefits to the fiscal bottom line; the importance of advocacy and fighting for resources at home; urban challenges that are specific to Los Angeles; the need to make ourselves more drought resistant; and the need to improve and upgrade our infrastructure so that co-occurring benefits such as – land preservation, education, and water conservation can take place.

The BHC made a special presentation to Assembly Member Sebastian Ridley-Thomas, 54th District. The inscription reads - "In recognition of his leadership to preserve and enhance the Baldwin Hills for the enjoyment of, and appreciation by, present and future generations." (The BHC extends its gratitude to the Honorable Assembly Member and his staff for their diligence.)

II. Approval of Minutes (April) - Sara Amir, Chair

The Chair called for a motion to approve the minutes. Member Boodnick so moved, Member Dixon seconded the motion, and a roll call vote was taken – **7 ayes**, **0 nays**, **0 abstentions**, **Minutes approved**. (One member was called away prior to vote.)

III. Public Comments - Sara Amir, Chair

Public comment was invited; however, no comments were made.

IV. Consideration of a Resolution Adopting the Baldwin Hills Conservancy Guidelines for Proposition 1 Competitive Grants – David McNeill, Executive Officer

Mr. McNeill - The BHC conducted public workshops in southern and northern California, to receive and address guideline comments and questions. There were 34 workshop attendees, with participants from Los Angeles Department of Water and Power, The Trust for Public Land, California Conservation Corp, and other interested groups. Mr. McNeill reviewed the Proposition 1 Guidelines* stating if adopted, the Guidelines could be published in July, and the conservancy could begin receiving grant solicitations in August (*Please see Attachment #1, page 9 BHC Proposition 1 Grant Program Guidelines.*)*. Mr. McNeill addressed questions regarding irrigation, landscaping, and the impact of the Governor's statewide directive of a 25% reduction in water use. He stated the design and development of projects are being impacted, and referenced Stoneview, already at a 20% reduction seeking an additional 5%. Mr. McNeill stated the BHC is trying to move toward recycled water in and is working through partnerships with MWD, the county, Culver City, Archdiocese, and the oil operator. Member Guiney mentioned the Los Angeles County Parks Department (LADPR) has a team working on this specific issue; a plan that is in sync with the State's plan; and where LADPR can reduce turf it is doing so.* Member Guiney reminded the board that in urban areas there are children and those that do not have a yard and/or grass, and that we are their lawn and front yard. He went on to say LADPR is taking a close, measured, and educated look, and working with elected leaders to make sure the facilities provided are what the communities expect. Member Guiney went on to say the LADPR is working in partnership with the BHC; has studied 177 parks; has 37 different water purveyors; has mapped each provider of recycled water, and where those lines are in relationship to the parks; with the goal of bringing in as much recycled water as possible. *(Member pointed out the medians at the Rose Bowl in Pasadena as a good example of high-tech green artificial turf replacement.)**

Member SAP mentioned another component is the historic nature of certain areas such as Will Rogers State Historic Park, and its polo fields located in a historic zone. Member Sap mentioned if a decision is made to let the fields die, the cost to bring them back would be expensive. He stated that State Parks has significantly reduced water, changed watering patterns, and is looking into purple pipe.

The Chair called for a motion. Member Guiney made a motion to adopt the Proposition 1 Guidelines, Member Boodnick seconded the motion, and a roll call vote was taken – **7 ayes, 0 nays, 0 abstentions, Approved.** (One member was called away prior to vote.)

V. Executive Officer Report: Project Status Update, Fiscal Update, Legislative Update - David McNeill, Executive Officer and Gail Krippner, Grant Program Manager

Project Status Update

Milton Street – Milton Street Park is moving forward with completion of the park portion anticipated in August.

Stoneview Nature Center – LADPR is working on construction documents. In keeping with the governor's water reduction plan, special attention has been given to features such as: how the roof pitches, rain barrels for watering the garden, drip sprinklers, and bubblers. This project is working on gaining Silver or Gold Leed Certification.

Stocker Corridor Trail – Earthwork began in March, and is moving quickly. An interesting feature is the specially engineered Geogrid retaining wall system. It is a prominent element of containing the hillside to make way for the ADA ramp to access the two parks.

Hetzler Road – The City of Culver City is working on City Council requests for the Hetzler Road Project's funding shortfall, the MRCA and BHRCA are also contributing.

USC – USC continues conducting data collection in the Baldwin Hills. Data is still being uploaded to the geospatial portal.

Loyola Marymount (LMU) – LMU has completed site visits to facilitate the survey locations for the summer. . Surveyors will be issued t-shirts with the Baldwin Hills Parklands Logo to wear while conducting the survey. They will be surveying in and around Rueben Ingold Park, Norman O. Houston Park, Baldwin Hills Scenic Overlook, between Culver City Park and Baldwin Hills Park, and on the Ballona Creek.

Fiscal Update

The fiscal year is coming to a close. BHC's staff is keeping in step with year-end processes and deadlines. In June we will begin interviewing for the Park and Recreation Specialist - Proposition 84, and anticipate hiring after the new budget begins. Once the budget passes, we can also anticipate interviewing for the Park and Recreation Specialist - Proposition 1. Once the reappropriation process takes place in July, we will have all active reappropriations for Proposition 40, and new grant opportunities available. (*Please see attachment pages 63-65.*)

Legislative Update

On April 27, 2015, Mr. McNeill attended the Natural Resources Committee hearing at the State Capitol regarding Assembly Bill 446. This is the legislation by Assembly Member Ridley-Thomas repealing the sunset date on the BHC. AB446 passed out of the Assembly Appropriations Committee.

VI. Board Member Announcements or Proposed Agenda Items for Future Meetings

Member Sap – The air conditioning unit at the Scenic Overlook is being overhauled.

Member Boodnick – The Baldwin Hills Scenic Overlook was named as one of State Park's three "historically and culturally significant sites" in an article by Patt Morrison of the Los Angeles Times. (*The article entitled "Park places" can be found at - <u>http://www.latimes.com/opinion/op-ed/la-oe-morrison-woods-20150520-column.html#page=1</u>)*

Member Katona – The County is also partnering with the Conservancy on a several other projects: Park to Playa –Segment C; Pedestrian access from Slauson Avenue up to the Five Points Intersection – This project is in design, and a community meeting is being planned to gain feedback. Sod improvements are continuing along Slauson Corridor and construction will begin on the north side between Angeles Vista and Overhill. Property owners on the north side of that block have signed on to this program. Street improvements will follow in 2016.

Ms. Bull-Arndt – David, Edsall, Deputy Attorney General (DAG) State of California Department of Justice will be the new liaison to the BHC. (*The BHC thanks Supervising Deputy Attorney General Christina Bull-Arndt for her diligence and commitment to the BHC.*)

(The BHC would like to offer a special thank you to Vice Chair Marina Voskanian and Board Member Yolanda Gorman for their hard work and assistance in drafting the BHC Proposition 1 Guidelines.)

The next board meeting is tentatively scheduled for July 31, 2015.

- **Re:** <u>Item 4: Consideration of a Resolution Amending Agreement #BHC13003 with</u> <u>University of Southern California for the Baldwin Hills Biota Update</u>

Recommendation: Staff recommends approving Resolution 15-01 authorizing the amendment of the performance period for Agreement #BHC13003 with University of Southern California (USC) for up to 12 months and adding data collection and modeling deliverables.

Background: The Baldwin Hills Biota Study Update has been underway since the fourth quarter of 2013. USC Dornslife Professor Travis Longcore has led the study team through several rounds of wildlife surveys to include: trapping, filming, and taking inventories of mammals, reptiles, amphibians, and bats that sustain the ecosystems within the parklands. The study has yielded substantial data that is being compiled for presentation on a website that will feature geospatial maps of the area wildlife. Based upon the preliminary wildlife findings submitted at the (January 2015) BHC Public Meeting, expectation for increased awareness of the biodiversity residing in the parklands is significant. The digital component of the project is also successfully developing. Over fifty percent of the vegetation classification polygon mapping has been completed using a combination of aerial photography and field visits. These maps will help identify habitat corridors, and allow for targeted native restoration activities.

As we approach the final stages of the project, staff has been presented with a change regarding the availability of the current project manager/lead scientist. Professor Longcore has been promoted to full tenure track status at USC. Per the attached letter (see attachment #1), USC notified staff of the new commitment at the University making him unable to compile and analyze the data for uploading into the public website this summer. After deliberating on whether to reassign the project to another manager or maintain Travis as project lead, staff concluded the benefits of maintaining Professor Longcore for the final stages of the project exceed the need to meet the current performance period deadline of August 31st. Some deciding factors in favor of an extension include:

- 1. An increase in months to collect and incorporate information from the volunteer observations through the iNaturalist online platform
- 2. An addition of habitat modeling for selected species for which sufficient observations have been obtained to develop range maps with the Baldwin Hills.

3. The requested extension does not impact the project cost.

Approval of the BHC amendment would be consistent with the resolution extending the matching grant funds availability for an additional 12 months as authorized by the Baldwin Hills Regional Conservation Authority on June 24, 2015.

Dear Mr. McNeill and Ms. Katona:

This letter requests a no-cost extension for the project Baldwin Hills Biota Update for the Baldwin Hills Conservancy (USC Account No. 53-4833-3002) and the Baldwin Hills Regional Conservation Authority (USC Account No. 53-4833-3770). The current end date for these awards is August 31, 2015.

Over the past 18 months we have successfully undertaken a range of biota surveys and mapping exercises that have updated and improved our knowledge of the species and habitats of the Baldwin Hills. Because of changes in my employment status, I am unable to put in the time that I intended wrapping up the project this summer. Although the survey work will be completed at the end of this month, we have significant work to do in preparing this information for the public website, which is under development. I therefore propose to extend the performance period for both awards one year to August 31, 2016.

My new position at USC is as a tenure-track professor, so I will be able to contribute some of my USC-paid research time to the project over the coming academic year, and to complete the website and final report deliverables by the end of next summer. This schedule has some advantages:

- 1. We will be able to introduce and maintain the biota website for a year prior to turning it over to one of the agencies. This will give time to get community feedback and improve it according to suggestions from users.
- 2. I will continue to maintain and incorporate information from the volunteer science project on iNaturalist. This community engagement tool has resulted in documentation of at least two species that have not been otherwise observed by our surveyors. The additional year may yield more unexpected results.
- 3. I will use the time to develop some species range maps that extrapolate the observations from the areas where we were able to survey (almost exclusively public land) to those areas not surveyed. This was not explicitly in the original scope of work but it is the logical next step given that the land owned by the Archdiocese was not open for on-the-ground surveys. Such maps will not be feasible for all species, but the additional time will give me the opportunity to work with my staff to do more interpretation of the raw survey results from our contractors (Natural History Museum of Los Angeles County and bat expert Stephanie Remington).
- 4. It extends the period of species surveys originally proposed through summer 2015 rather than



stopping surveys in spring 2015.

Fallen Fruit will activate ritual and community through a series of six recognized public participatory projects to spark engagement and celebrate the Park, the Public and the diverse communities of Los Angeles County throughout one calendar year. These events can occur at the Communal Table in the Outdoor Room, or within the Gardens.



Early Spring **Public Fruit Tree Adoptions**

Working with a variety of donors or organizations like TreePeople and civic groups, Fallen Fruit distributes free bare-root fruit trees in a variety of urban settings. We encourage the planting of these trees in either public space or on the periphery of private property, in order to create new kinds of communal life based on generosity and sharing. Each recipient signs an adoption form promising to care for the tree — initiating a relationship with it.

Spring Tomato Hootenanny

Join Fallen Fruit for the Tomato Hootenanny. Adopt a tomato plant, get down with some square dancing, and take part in a seedling workshop to celebrate and learn all things tomato. Download a tomato plant adoption form.

Late Spring **Public Fruit Meditation**

An array of meditations and visualizations designed for small groups in intimate settings. Each sequence imagines fruit differently to raise consciousness about symbolic values, politics, social relations and fruit itself. Working within individual consciousness as well as interpersonal relationships, the various parts reconfigure how we might think about fruit and use it as a personal and social tool.

Early Summer Lemonade Stand

We are interested in temporary community and new forms of public. In exchange for drawing a self-portrait onto a lemon, each participant receives a glass of organic lemonade. Collectively the lemon selfportraits create a new form of public that illustrate some of the archetypes that construct community. Handdrawn expressions illustrate joy and innocence as well as wisdom and age. A microphone installed at the stand records real-time story telling. Story telling prompts such as; Describe the "best" day in your life? Or the opposite, In life sometimes there are days of profound difficulty and how did this moment change the way you see yourself? The Lemonade Stand activates the phrase ... "when life gives you lemons..."

Mid Summer **Public Fruit Jam**

Fallen Fruit invites the public to bring homegrown or street-picked fruit and collaborate with us in making a collective fruit jams. Working without while listening and dancing to salsa recipes, we ask people to sit with others they do not already know and negotiate what kind of jam to make: if I have lemons and you have figs, we'd make lemon fig jam (with lavender). Each jam is a social experiment. Usually held in a gallery or museum, this event forefronts the social and public nature of Fallen Fruit's work. and we consider it a collaboration with the public as well as each other.

Late Summer Salsa Salsa

Come to SALSA SALSA, a harvest festival for the citizens of Los Angeles - come make and taste tomato salsas music. Meet new people and talk about the future shape and texture of life in this city, including the artists and organizers listed above. Bring your homegrown or street-picked tomatoes (or peppers, or peaches) and collaborate with your neighbors on new and remarkable salsas. Bring a friend and some tomatoes or peppers from your yard - this event is free to the public.

<u>Recommendation</u>: Staff recommends approving Resolution 15-02 recommending the dedication of a segment of the Park to Playa Trail in recognition of Director Russ Guiney

Background: Russ Guiney's work in the Baldwin Hills began with California State Parks during the development of the Baldwin Hills Park Master Plan. As Angeles District Superintendent, Mr. Guiney played an integral role in putting State Parks at the forefront of the urban parks movement. During the two year Master Plan development process, from 1999 to 2001, Russ became the face of State Parks at dozens of community and stakeholder meeting map in urban Los Angeles. In the midst of planning the first large scale American urban park in nearly one hundred years, Russ diligently pushed for State funds to help purchase the 65-acre Baldwin Hills Scenic Overlook. The \$30 million acquisition of the site in December of 2000 would mark the biggest urban park investment in State Park's history.

When Senator Murray crafted legislation for the Baldwin Hills Conservancy in 2000, it was fitting that Russ would serve on the BHC board as the designee for State Parks Director Rusty Areias. From that time forward, Russ has had a seat at the table for all of the improvement, management and expansion projects in the Baldwin Hills Parklands. His departure from the State family to the County family in 2002 did not take him far from the Parklands. He became a board member of our partner agency, the Baldwin Hills Regional Conservation Authority, and a top representative for Kenneth Hahn State Recreation Area's operating agency, the Los Angeles County Department of Parks and Recreation. Russ has served with distinction and honor during his tenure in the Baldwin Hills, and the resolution is offered as a gesture of gratitude from all the partner agencies that have had the pleasure of working under his guidance and leadership.

Legislative Update

Baldwin Hills Sunset Date Repeal: On June 1st, AB 466 – Ridley-Thomas, was heard in on the Assembly floor and passed on a 77-0 vote. The bill was ordered to the Senate, Natural Resources and Water Committee where it was heard on July 14th. The Committee passed the bill on a 9-0 vote. Currently the bill is awaiting an August 17th Senate Appropriations Committee hearing.

Projects Status Report

Culver City has successfully followed through with efforts to close the funding gap for the Hetzler Road Pedestrian Path project, agreement #13002. The City has received commitments from State Parks, Culver City Council, the Mountains Recreation and Conservation Authority and the final \$100,000 from the Baldwin Hills Regional Conservation Authority (Attachment #1) to meet the budget shortfall and move forward with negotiating a revised contract with project's selected bidder. Once a new agreement is finalized a new timeline will be created to implement the project over the next 12-16 months.

Dear Chairperson Ridley-Thomas:

Thank you for your ongoing leadership and support for the Baldwin Hills Scenic Overlook. As you know, over the past several months, the City of Culver City has been working with California State Parks, Baldwin Hills Conservancy (BHC), and the Mountains Recreation and Conservation Authority (MRCA) to fund, design, and construct a pedestrian trail at the Scenic Overlook, which is also an important link in the planned Park to Playa Trail. The proposed trail would help to alleviate an on-going safety problem due to conflicts between pedestrians and vehicles on Hetzler Road. Hetzler Road, the State Park Road that leads up to the Scenic Overlook, also serves as the sole means of access to a number of residential lots located adjacent to the roadway. Currently, this vehicular roadway is also used as a trail for hikers who prefer using a paved pathway to the more rugged dirt paths in the Park.

In order to alleviate this problem, a 10' wide paved trail has been designed, which will be constructed parallel to the roadway up to a point past the residential properties (approximately 1,500 feet in length). This new paved trail will provide a safer surface, separate from the roadway, for hikers to use. Culver City has agreed to assist State Parks with this project by putting it out to bid and managing the construction of this trail. Last year, the BHC Board approved a grant to Culver City for the project in the amount of \$791,000, to fully fund the project. Unfortunately, when the project bids were received earlier this year, it became apparent that the BHC grant was insufficient to fully fund the project.

To close the funding gap, the project partners have worked together to modify the project scope, and State Parks has agreed to take on work that was originally included in the project scope. These project modifications have reduced the costs significantly to a revised total construction cost of \$1,101,000. Further, the project team has secured

additional funding sources through a Land and Water Conservation Fund Grant and the Culver City's General Fund.

To completely fund the construction of the project, the City of Culver City is respectfully requesting your support for a \$100,000 BHRCA grant.
