PUBLIC MEETING MINUTES BALDWIN HILLS CONSERVANCY Friday, March 06, 2015

Call to Order

A public meeting of the Baldwin Hills Conservancy (BHC) was assembled at 10:00 a.m. on Friday, January 16, 2015, at the Kenneth Hahn State Recreation Area Community Center, located at 4100 South La Cienega Boulevard, Los Angeles, CA 90056.

I. Roll Call

II. Approval of Minutes (December) - Sara Amir, Chair

The Chair called for a motion to approve the (January) minutes. Member Guiney made a motion to approve, Member Reynolds seconded the motion, and a roll call vote was taken – **7 ayes**, **0 nays**, **2 abstentions, Minutes approved.**

III. Public Comments - Sara Amir, Chair

Public comment was invited; however, no comments were made.

IV. Discussion and Possible Action on the Baldwin Hills Conservancy Draft Guidelines for Proposition 1 Competitive Grants – David McNeill, Executive Officer

Mr. McNeill explained that voters approved Proposition 1 in November allowing funding to come to multiple agencies within the State of California for water improvement projects. Focus is on expending funds with transparency, and allowing for competitive applications for projects within respective agency territories. Mr. McNeill stated the BHC is working with California Natural Resources Agency (CNRA) on a framework for guidelines, and has submitted a schedule to CNRA with July as the grant solicitation target date. The BHC will send the draft guidelines to CNRA for initial comments after approval; then post them online on CNRA's designated "Bond Accountability" webpage for 30-day Public Notice. In accordance with Section 79706 [b] (*"Local conservancies only need to have meetings within their boundaries.*") the BHC will be conducting public meetings at the Scenic Overlook, Kenneth Hahn Park, and perhaps one with a sister agency. After those meetings are held and comments are taken, the guidelines will be submitted to the CNRA for review and approval. Once approved, they will be returned for board approval. Afterwards, they will be posted on a designated page for accountability, allowing us to move forward to the solicitation period.

Mr. McNeill went over the draft guidelines with the board and community members. In line with the BHC's mission, the bond gives the BHC many areas to work with in terms of water. The governor's water action plan relies on people understanding the need to conserve water so <u>education</u> will be part of our outreach on water. <u>Restoration</u> is also a part of the water act, as is <u>habitat preservation</u> allowing ecosystems to maintain a balance and address <u>water quality</u>. <u>Managing public lands</u> includes irrigation, trying to obtain recycled water, and building projects to capture storm water. Proposition 1 allocates \$10 million to the BHC for competitive grants for multi-benefit ecosystem, watershed protection, and restoration projects, pursuant to the code.

- LMU updated the park survey to include 30 new questions and eliminate nine former questions
- This is the second round of surveying as part of the study that began last year
- We still have the question on how far folks travel to get to the park
- We have changed the survey locations and turned them into zones (Please see Attachment #1 Baldwin Hills Comprehensive User Survey: Draft – 2/25/15.)
- LMU students conducting the survey will be given Baldwin Hills Parklands T-shirts
- The Survey will be done on electronic tablets (allowing for better collection of data and dissemination of BHC information.)

Members discussed

VI. Executive Officer Report – Project Status Update, Fiscal Update, Legislative Update - BHC Staff Representative - David McNeill, Executive Officer and Gail Krippner, Grant Program Manager

Project Status Update Presented by Gail Krippner

Milton Street Park – The MRCA is making significant construction progress at the park. They are still working on permits for the Green Street and may need to be rebid. Completion of the park section is slated for this spring/June.

Stoneview Nature Center – L.A. County Parks and Recreation is in the site design process, the landscaping, and the inside of the Nature Center are under review. Project completion is expected winter of 2016.

Stocker Corridor – The MRCA held construction kick-off in February. Per the BHC January Public Meeting, the upper portion of the stairs were removed from the scope, construction is slated to begin later this month, and expected to be completed in 2016.

Hetzler Road – The pedestrian path ran into a budget shortfall based on bids they received. Partners are looking for funds to make up that shortfall. They are going to rebid. Mr. McNeill directed everyone to Attachment 1A, and stated that the Conservancy authorized \$791,000 for the project, and that there was a match to get the difference for the total project. The new gap is \$644,000. Mr. McNeill pointed out that a lot of meetings are taking place to try and rescue the project. It is a public safety issue if unaddressed. There is concerted effort being made at the Culver City Public Works Department, the MRCA, and State Parks. Discussions are taking place regarding lowering the amount by State Parks doing some of the work, and Culver City taking on a portion of the cost.

Fiscal Update Presented by David McNeill

Please see Attachment #2 – 2014/2015 Summary Sheet by fund; Attachment #3 – Bond Cash Fund. The BHC is operating on a straight line in terms of office and staff expenditures. We will be purchasing a little more equipment; but nothing over \$5,000.

Our Capital Outlay Program appropriations are current for existing Prop 40 and Prop 84 projects. By July our expired Proposition 40 appropriations should be renewed. We have appropriations to continue to grant to new Proposition 84 projects over the next three years. Then, once appropriated, we will have 10 million for Proposition 1 projects as well.

No hiring will take place until our 2015-16 budget is approved.

VII. Board Member Announcements or Proposed Agenda Items for Future Meetings

Mr. McNeill - Assembly Member Sebastian Ridley-Thomas put forth AB466 to repeal the BHC sunset date. A similar bill is being put forward by Speaker Toni Atkins to eliminate the sunset date on the San Diego River Conservancy.

Mr. McNeill – Reminder that Form 700s are due before Wednesday, March 25, 2015, or a fine can be incurred.

Chair Amir – (*Meeting dates were brought to the table. Note taker will follow up.*) – Two Public Meetings are tentatively moved to April 17th and May 29th.

Member Sap – The Baldwin Hills Terrace Special Events Space at the Overlook should be completed by the end of the month, it should be nice for small receptions, and potentially a concessionaire to run that area. We are looking forward to opening that underutilized space.

Member Dupont-Walker – Metro has opened a business solutions center to deal with some of the impact issues as a result of the Crenshaw/LAX Line construction. It is there to assist businesses between 48th and 60th Streets. This weekend is the 50th Anniversary of Selma.

Member Jones – Complemented and thanked the BHC staff and board members for the quality of service and work they provide; for their commitment to conservation, this community, and the protection of resources for the benefit of all.

Lacey Johnson (Supervisor Mark Ridley-Thomas' Office) – We created a project map that shows all of the capitol projects that have been completed in the Second District since the Supervisor has been in office (Since 2008.) There are over 200 projects listed, that represent over a 4 billon dollar investment in the district. We anticipate that it will be over 6 billion by year 2020. What is creative about the map is that is overlaid with a timeline. You can look at the district in 2008, and as the timeline moves forward all of the projects populate on the map. You can sort by six-seven categories – Parks, Paths, Open Spaces; Affordable Housing; Transportations; and other areas. *Website address: http://ridley-thomas.lacounty.gov/communitydevelopment/investing-in-communities/*

Members Reynolds – We have been working with the BHC on the Culver Park section of Park to Playa. We are ready to go over the next steps of the grant application process. We are also assessing design and cost for the ADA structure component, and are excited about moving forward.

Recommendation: Adopt Resolution 14-11 authorizing the Executive Officer to amend the scope and budget for the Hetzler Road Pedestrian Path Agreement pursuant to provisional reductions to be finalized by Culv er City Public Work s, the bid contractor, ARC Construction Inc, and California State Parks.

Background: In January of 2014, the BHC Govern ing Board authorized a grant to Culver City Public Works in the amount of \$791,000 pursuant to Resolution 14-02. The grant was awarded for the construction of a 10 foot wide paved pedestrian ac cess point to the Baldwin Hills Scenic Overlook that would separate pedestrians from vehicular traffic. This planned improvem ent is a public safety priori ty that is supported by California State Parks, Culver City, park users, and community members. The schedule for construction was amended last summer due to forecasts of heavy rain that might have caused erosion issues.

In a February 13, 2015, projec t update let ter, Culver City D epartment of Public Works explained that there was a \$633,000 budget shortfall between the grant budget and the lowest of eight (8) construction bids for the project. The Depar tment was preparing a request to the City Council to reject all bids and consider re-bidding the project while placing the project on indefinite hold. Over the course of the followin q weeks, the Department was able to negotiate a three (3) month extension for the acceptance period of t he lowest bidder, ARC Construction Inc, and the opportunity to revise the able funding. At present, the proposed scope to get the most out of the avail construction contract for the project has been revised downward from \$1,164,033 to \$836,133 (see Attachment #1). Applying the provisional contract amount, the projected shortfall currently stands at \$269,133. The Department, L.A. County, MRCA, and State Parks are working with stakeholders to identify funding sources to meet the gap on or before the deadline of June 5, 2015.

RESOLUTION AUTHORIZING THE EXECUTIVE OFFICER TO AMEND THE SCOPE AND BUDGET FOR THE HETZLER ROAD PEDESTRIAN PATH AGREEMENT **#BHC 13003** PURSUANT TO PROVISIONAL REDUCTIONS TO BE FINALIZED BY CULVER CITY PUBLIC WORKS, ARC CONSTRUCTION INC., AND CALIFORNIA STATE PARKS.

WHEREAS, under Division 22.7 of the California Public Resources Code, the Baldwin Hills Conservancy was created to acquire open space and manage public lands within the Baldwin Hills area and to provide recreation, restoration and protection of wildlife habitat within the Conservancy territory; and

WHEREAS, Public Resources Code 32569 (a) states the Conservancy may award grants to local public agencies for the purposes of its division; and

WHEREAS, the City of Culver City is a local public agency incorporated as a city in 1917; and

WHEREAS, pursuant to Public Resources Code 75060, funds from the Safe Drinking Water, Water Quality and Supply, Flood Control, River and Coastal Protection Bond Act of 2006 are available for projects in the Baldwin Hills and Ballona Creek Watershed to promote access to and enjoyment of the coastal resources of the State; and

WHEREAS, pursuant to Resolution 14-01, the Governing Board awarded \$791,000 in BHC Prop 84 bond funds to Culver City Public Works for the construction of the Hetzler Road Pedestrian Path; and

WHEREAS, the scope of work and budget for grant agreement #BHC 13003 does not include the additional funds needed for Culver City Public Works to execute a bid award contract with the lowest bidder, ARC Construction Inc; and

WHEREAS, provisional reductions to the scope and budget to help lower the funding gap are being negotiated between Culver City Public Works, ARC Construction Inc, and California State Parks; and

WHEREAS, the BHC seeks to see the project implemented for the safety and well being of park visitors; and

WHEREAS, as under Public Resources Code 15333 this action is exempt from the environmental impact requirements of the California Environmental Quality Act (CEQA); now

THEREFORE BE IT RESOLVED, THE BHC GOVERNING BOARD:

1. AUTHORIZES THE EXECUTIVE OFFICER TO AMEND THE CONTRACT SCOPE AND BUDGET FOR AGREEMENT #BHC13003 PURSUANT TO PROVISIONAL REDUCTIONS TO BE FINALIZED BY CULVER CITY PUBLIC WORKS, ARC CONSTRUCTION INC, AND CALIFORNIA STATE PARKS

<u>Recommendation</u>: Approve Resolution 14-12 authorizing an eighteen (18) month extension to the performance period for the Milton Street Park Agreement #BHC12000 with the MRCA.

Background: Milton Street Park is currently under construction pursuant to Resolution 12-06 which authorized a grant of \$2,000,000 in BHC Prop 84 funds for a 1.2-acre park and a Green Street along the Milton roadway. The project is located adjacent to the Ballona Creek Bicycle Path and Del Rey Middle School in the City of Los Angeles (Attachment #1).

The park portion of the project was successfully permitted, and is within budget with a scheduled completion date of June 2015. As detailed in the letter from the MRCA, delays in the final permitting for the Green Street portion of the project have continued (see Attachment #2). BHC staff has been apprised of the situation, and supports the recommendation to extend our Prop 84 grant fund availability through 2016 in order to maintain the Santa Monica Bay Restoration Commission's \$200,000 match for the Green Street construction. This unique feature is a critical piece of the water quality component of the project. If permitted, it would be the first Green Street in the 11th District of the City of Los Angeles, and would provide a template for future innovative storm-water capture projects throughout the City.

Term Extension Request Ballona Creek - Milton Street Park Grant Agreement: BHC 12000

Dear Mr. McNeill,

The Mountains Recreation and Conservation Authority (MRCA) would like to request a term extension for the above-referenced grant. The current performance period for this grant extends through June 30, 2015 and we would like to request an extension through December 31, 2016 for the reasons outlined below:

Although the park portion of the project will be constructed by June 2015 and open to the public this summer, numerous delays for the green street portion have been caused by the lengthy plan review and permitting process required by the City of Los Angeles. Coordination between the various reviewing departments (Bureau of Engineering, Department of Transportation, and Bureau of Street Services) has been extremely challenging, cumbersome and time consuming. Although every effort was made by the MRCA and our consultants during the design process to keep the City up-to-date on the green street planning, it appears that the approval process is being hindered since very few of these types of projects have been reviewed, built or permitted within the City. Confusion between different City departments over the need for a revocable permit along with maintenance and liability issues appear to be at the core of the delays. Staff is working to get clear direction as to what the actual requirements are since we are receiving new and conflicting information from the different divisions of the City. MRCA is doing everything possible to both clarify and expedite the tasks required to move this project forward. As a result of this new information and possible additional requirements, Staff has determined that at this point in time the street improvements will have to be a second phase of the project and bid again separately after the park has been constructed and after permits and agreements are obtained from the City.

The green street component is a critical piece of the overall project and has been designed to complement the park both visually and functionally. A key feature of the design are the Vegetated Stormwater Curb Extensions (VSCE's) - which serve to

capture, treat and infiltrate wet and dry weather urban runoff. Additionally, a portion of the drainage from the park will flow into the VSCE's, thereby increasing their inherent value. The net effect will be less pollutants being expelled into Ballona Creek, thereby improving the habitat potential and water quality both in the Creek, and in the Pacific Ocean. In addition to the stormwater treatment, there are many other benefits of the green street that the funding will be helping to achieve: 1) replenish the groundwater supply, 2) educate the public about BMPs and promoting infiltration, 3) promote green street projects so that other agencies / cities can reproduce it, 4) provide an additional aesthetic enhancement to the neighborhood, 5) install native trees where none currently exist (which has a multitude of benefits all on its own including improvement to air quality), 6) reduce impervious surfaces, 7) provide a "green connection" between the park and the school / neighborhood, 8) improve pedestrian and bicycle safety, and 9) calm traffic.

The green street is being funded by the Baldwin Hills Conservancy (Conservancy) and the Santa Monica Bay Restoration Commission (SMBRC - \$200,000). As we have identified the Conservancy's grant as a match for the SMBRC funding, should this requested time extension not be granted, we will be unable to complete the green street and stand to lose the SMBRC funds as a result. This will more than likely guarantee that the green street, with all of its benefits, will not be constructed anytime in the near future. As both time and money has already been invested in developing the plans, paying plan check fees, processing comments, and coordinating with consultants and the City, the MRCA would very much like to see this piece of the project implemented.

Overall projected schedule: As mentioned above, the park is scheduled to be completed soon and opened to the public this summer. Assuming we are able to work out all City requirements for the green street component by the end of 2015, MRCA will re-bid the green street and start construction in 2016 following bid review, selection of a general contractor, MRCA Board approval and procurement of permits. The timeline for the actual construction would likely be approximately four months, followed by punch list items, potential dedication and grant close-out activities by December 2016.

WHEREAS, the Mountains Recreation and Conservation Authority (MRCA) has requested to amend the agreement for eighteen (18) months pursuant to the letter and revised timeline included in the April 17, 2015 staff memorandum.

WHEREAS, as under Public Resources Code 15333 this action is exempt from the environmental impact requirements of the California Environmental Quality Act (CEQA); now
