**<u>Recommendation</u>**: Approve Resolution # 21-01 authorizing a BHC Proposition 84 Local Assistance Grant, in an Amount Not to Exceed \$19,941, to Honeylove Urban Beekeepers for the Stoneview Nature Center Sanctuary Apiary

**Background:** Honeylove Urban Beekeepers has submitted an application for Prop 84 funds for the Stoneview Nature Center Sanctuary Apiary (see Attachment #1.) The \$19,941 project represents a collaborative partnership with Los Angeles County Parks and Recreation that would establish a utilitarian honeybee colony in the Parklands for observation, staff training, interpretation and educational programming.

The proposal brings the opportunity to help address Colony Collapse Disorder in a densely populated urban setting. Since it was first identified in 2006, Colony Collapse Disorder has decimated the world's Honeybee population. Despite extensive scientific research there still isn't a definitive answer to what causes the collapse or a solution to stop it. Through the advocacy of its initiatives, Honeylove achieved success in 2015 when the City and County of Los Angeles legalized beekeeping in residential neighborhoods, parks and other urban open spaces, paving the way for the health of our urban Honeybee population to improve.

The installation of a formal apiary in the Baldwin Hills Parklands would provide the infrastructure necessary for Honeylove Urban Beekeepers to deliver ongoing training and interpretive programming to visitors at Stoneview Nature Center at no additional cost. The applicant will provide an in-kind contribution of \$6,647 towards the design and construction of the project, which exceeds the 25% match requirement.

The application was assessed using the criteria adopted by the BHC Board in April 2011. The proposed scope of work includes:

- Constructing a 35 x 35 ft Sanctuary Apiary on Los Angeles County land adjacent to Stoneview Nature Center to house rescued honeybees.
- Constructing a 30 x 30 ft gravel base public viewing platform, and adjoining 8 x 16 ft storage shed, enclosed by a chain link fence with native vines to provide local resident privacy.
- Installing a small water feature powered by a solar water pump (CA's Food and Agriculture Code has a 50 ft adjacency water requirement for beehives)
- Procuring up to three observational hives: (1) Portable Hive that may be used for classroom presentations; (1) Outdoor Full Hive with side observation panels for used during nature walks; (1) Full Indoor/Outdoor Fixed Location with two-sided Glass Panels.

The criteria review of the project application successfully corresponded with the following four goals of the Baldwin Hills Park Master Plan, and the BHC's Strategic Plan: 1) increases active recreation opportunities for underserved communities; 2) provides for public access and entryways, 3) protects and restores natural habitat; 4) emphasizes connections between existing parks, trails, and urban streams.

#### c. Consistency with purposes of Prop 84 statute

PRC 75060: Bond funds are available for projects to promote access to and enjoyment of the coastal resources of the State.

#### d. Consistency with the Baldwin Hills Park Master Plan (BMPMP)

Pedestrian Access and Trail Connections, page 46: "Key public access points would allow easy connections to major public trails and access into the park."

Education and Interpretation, Page 76, BHPMP: "Providing opportunities for outdoor education and use of the Baldwin Hills Park as a living laboratory is a primary management goal. Protecting and restoring natural habitat shall be coordinated with education programs whenever possible, in conjunction with park-provided visitor interpretive programs, area schools, after-school and other youth programs."

#### e. Greater-than-local interest

With nearly 3 million Californians residing in a five-mile radius of the Baldwin Hills territory (according to the 2000 census data), and over 58 million tourist trip visits to the Los Angeles area annually, the land resources in the Baldwin Hills represent an extraordinarily unique value to the entire state.

#### f. Demonstrated expertise in the proposed program area

Honeylove Urban Beekeepers has over a decade of extensive experience

establishing and managing large and small bee colonies throughout the LA basin including at Griffith Park in the City of Los Angeles.

# **ADDITIONAL PRIORITIES**

#### • Leverage

Funding leverage includes Honeylove Urban Beekeepers' in-kind match of \$6,647, which is a 33% contribution towards the BHC award request.

#### • Resolution of more than one issue

This project resolves multiple issues to include: addressing the environmental threat to local bee populations; improving natural pollination of ecosystems and its connection to improved biodiversity; educating the public on conservation of species and native habitats; providing public access and interpretation.

#### • Readiness

Honeylove Urban Beekeepers' is ready to implement the project and has sufficient available staff to begin work immediately. Los Angeles County Parks has demonstrated their commitment to support the project.

## • Realization of prior BHC goal

The project improves upon the existing "Bee Hotel" concept at Stoneview Nature Center by installing a proper and functioning apiary for honeybees. The programming aspect also meets part of the nature interpretive goals as promulgated in the Baldwin Hills Park Master Plan.

WHEREAS, pursuant to Public Resources Code 75060, funds from the Safe Drinking Water, Water Quality and Supply, Flood Control, River and Coastal Protection Bond Act of 2006 are available for projects in the Baldwin Hills and Ballona Creek Watershed to promote access to and enjoyment of the coastal resources of the State; and

WHEREAS, the Honeylove Urban Beekeepers adopted Resolution approving the submission of an application for local support from the BHC Prop 84 funds; and

WHEREAS, Honeylove Urban Beekeepers has submitted an application for a BHC Proposition 84 local assistance grant for the STONEVIEW NATURE CENTER SANCTUARY APIARY; and

WHEREAS, Los Angeles County Department of Parks and Recreation has partnered with the Honeylove Urban Beekeepers to successfully plan and implement this project with a commitment to cooperatively manage the improvements upon negotiated completion and terms; and

WHEREAS, the objectives of the project are consistent with the funding source and grant requirements adopted by the BHC under Resolution 10-06; and

WHEREAS, pursuant to Public Resources Code 32565.5 (b) the BHC shall give priority to related projects that create expanded opportunities that provide recreation, aesthetic improvement, and wildlife habitat in the Baldwin Hills Area; and

WHEREAS, as under Public Resources Code 15333 this action is exempt from the environmental impact requirements of the California Environmental Quality Act (CEQA); now

NOW, THEREFORE BE IT RESOLVED, that the Baldwin Hills Conservancy hereby:

## Proposition 84 Grant Request Sanctuary Apiary December 31, 2020

Submitted by: HoneyLove

#### **PROJECT NARRATIVE / SCOPE**

Los Angeles County and HoneyLove have agreed in principle to a partnership arrangement based upon the document issued on 11-25-19 and amended for clarity on 4-17-20. (See attached Appendix). The arrangement includes various initiatives to support the County with educational program development and execution, staff training and ongoing public education sessions, installation and maintenance of Honey bee observation hives within the park, conducting Honey bee rescues and <u>establishing a Sanctuary Honey bee Apiary</u>. Exhibit 1 is submitted as evidence of Los Angeles County's support of this Grant Request and the County's willingness to grant HoneyLove a Land Use Agreement.

This Proposition 84 Grant request is specifically related to:

- Establishing a 35 x 35-foot Sanctuary Honey bee Apiary on County land adjacent to Stoneview Nature Center to be used to house rescued Honey bees and conduct "open hive" educational classes on a 30 x 30-foot gravel base enclosed by a chain link fence with native vines to provide local resident privacy with an adjoining storage shed.
- Installation of observation bee hives within the Nature Center to provide visitors the opportunity to observe Honey bees during nature walks and/or educational sessions in the Community Room.

The remainder of this document provides a detailed description of the proposed Apiary, the underlying rationale for the initiative and an overview of how the proposal supports Proposition 84's Goal and Objectives.

#### **Apiary Description**

#### **Location**

- Land between La Cienega Blvd and Stoneview Nature Center behind an existing privacy wall.
  - Exhibits 2 and 3 contains "Required Maps" showing location.

#### Physical Requirements (See Exhibit 4)

- 35ft. x 35ft. area surrounded by a 6 ft. chain link fence with slats or screen
  - For long term privacy of local homes, a California native vine or other plant acceptable to County arborists will be planted around the fence.

- 30ft. x 30ft. on crushed gravel base on landscape fabric to prevent weed growth.
  - Flat area will be created by establishing an 18 to 24 inch retaining wall. (See Exhibit 3).
- 8 x 16 shed on a 4 x4 base for storage and to provide additional privacy for local homes.
- A water source comprised of a small creek & pond with a solar powered water pump.
  - Water within 50ft of hives is an LA County requirement of apiaries.

#### **Observation of Honey bees**

We propose 3 different types of equipment that may be used for Honey bee observation.

- 1. Portable Hive that may be used for classroom presentations.
- 2. Outdoor Full Hive with Side Observation Panels for use during nature walks.
- 3. Full Indoor/Outdoor Fixed Location with two-sided Glass Panels.

#### Asset Ownership

Los Angeles County will own of any and all assets acquired through funding per this request. However, any and all bee hives and beekeeping equipment not funded by this grant request will remain the property of Honeylove and/or individual beekeepers participating the overall program.





#### **PROJECT TIMELINE**

We anticipate 100% of the work to build the Apiary will be accomplished by volunteers during weekends. Based upon the 12 major tasks outlined below, we anticipate the total elapsed time to build the Apiary to be approximately 12 weeks.

#### PROJECT COSTS

We estimate that the total cost of the Project is \$28,452.56<sup>1</sup> with material costs totaling \$15,957.56

• Exhibit 5 provides a Summary of the Total Project Cost by Task as well as supporting detail regarding the anticipated labor hours and related hourly cost by type of work<sup>2</sup> and material costs associated with each Task.

anticipated labor to be provided as an "In-Kind" Donation equaling \$12,495, which equates to 44% of the total cost, exceeding the minimum requirement by a significant margin.

All HoneyLove Volunteers will sign a waiver of liability protecting the Baldwin Hills Conservancy, the State of California and County of Los Angeles.

#### **Rationale for the Proposed Project**

Roughly one third of the world's food depends upon Honey bees for pollination. Unfortunately, worldwide the Honey bee population is under siege.

Since it was first identified in 2006, Colony Collapse Disorder (CCD) has decimated the world's Honey bee population. CCD is when all the adult Honey bees simply disappear from the hive, all at the same time. Despite extensive scientific research there still isn't a definitive answer to what causes CCD, nor is there a solution. CCD is believed to be complex and the result of multiple factors. One study evaluated 61 factors and found that no single stressor stood out as the primary cause of CCD.

Tragically, fourteen years since it was first encountered the impact of CCD is still being felt. On July 5, 2019, the Washington Post reported *"This past winter saw the highest Honey bee colony losses on record."* If there is good news related to Honey bees, it's coming from Urban Beekeepers across the country. As referenced in a February 2014 article entitled *"Can Urban Beekeeping Stop the Beepocalypse?" https://science.time.com/2014/02/13/can-urban-beekeeping-stop-the-beepocalypse/* there is substantial potential for urban beekeepers to play a key role in the preservation of Honey bees. Urban Beekeepers have experienced significantly less CCD than commercial beekeepers. The proposed Apiary will contribute to preserving Honey bees as a key natural resource.

#### **Proposed Project & Proposition 84 Goals**

We believe that the goals to <u>increase active recreation opportunities for underserved</u> <u>communities</u> as well as <u>emphasize the connection between existing parks, trails, and urban</u> <u>streams</u> will be addressed via the Educational Programing and physical presence of Honey bees in and around Stoneview Nature Center. Specifically, the observation hives and the educational services and support by HoneyLove will provide visitors an opportunity to view Honey bees and increase public awareness of the vital importance of pollinators as well as the many challenges facing pollinators from pesticides, parasites, habitat loss, etc.

In addition, the Sanctuary Apiary will provide unique hands-on educational opportunities and promote Urban Beekeeping. Further, in and of itself the Apiary can prevent the needless extermination of feral Honey bee colonies in the Baldwin Hills Ballona Creek area. Feral colonies are being routinely euthanized by LA County Vector Control, the Fire Department and professional exterminators. One of the key reasons is that there are not enough Urban Beekeepers and by LA City Ordinance, Urban Beekeepers are limited to 2 colonies per private residence. Absent the proposed Apiary there are limited locations for Urban Beekeepers to locate rescued colonies.

With respect to <u>protecting and restoring natural habitat</u> we would like to point to an unprecedented 2018 study conducted by the University of California San Diego that found "that Honey bees are the world's most important single species of pollinator in natural ecosystems and a key contributor to natural ecosystem functions." <u>https://www.sciencedaily.com/releases/2018/01/180110101005.htm</u>

In terms of how the Proposed Project will <u>protect watersheds connecting to Santa Monica Bay</u>, we believe a research initiative outlined in the Journal of Earth Science & Climatic Change titled <u>Beekeeping as Integrated Watershed Conservation and Climatic Change Adaptation: An Action</u> <u>Research in Boredo Watershed</u> is noteworthy. <u>https://www.omicsonline.org/open-access/beekeeping-as-integrated-watershed-conservation-and-climatic-change-adaptation-an-action-research-in-boredo-watershed-2157-7617.1000213.php?aid=29441</u>

The research concluded that watersheds utilized by beekeepers enjoyed enhanced watershed conservation and climate change adaptation as a result of beekeeper efforts.

Based upon the above we believe the proposed Apiary addresses the following Proposition 84 Goals:





#### OBJECTIVE

Establish a mutually beneficial relationship between the Los Angeles County Department of Parks & Recreation (LACDP&R) and HoneyLove.org (HoneyLove) centered around protecting Honeybees and educating the citizens of Los Angeles County about Honeybees and the vital role they play in the food chain as well as to promote Urban Beekeeping.

#### BACKGROUND

HoneyLove <u>http://honeylove.org/</u> is a 501 3c, Not for Profit organization based in Culver City, California whose mission is to "Protect honeybees by educating communities and inspiring new Urban Beekeepers".

Most people are aware that fully one third of the food that we eat is available because it is pollinated by Honeybees. Unfortunately, if they read the paper or listen to the news they are also aware that worldwide the Honeybee population is under siege.

"Contrary to what one might expect, urban bees survive better, produce more honey, and are healthier than rural bees."

Further, as reference in that same article, as well as in a July 14, 2014, Time Magazine article *"Can Urban Beekeeping Stop the Beepocalypse?"* <u>http://science.time.com/2014/02/13/can-urban-beekeeping-stop-the-beepocalypse/</u>, in 2015 the City of Los Angeles got the message and legalized Urban Beekeeping in the City of Los Angles reversing an ordinance making it illegal 136 year earlier.

At the time Los Angeles Councilman Paul Koretz said

"This arose from the neighborhood council system," "It started in Mar Vista, was vetted through the NCs—over twenty neighborhood councils from throughout the city have sent in their support. Bees are dying worldwide—in LA we're putting out the welcome mat. They are vital to our survival."

I'm proud to say that HoneyLove.org was responsible for launching the initiative that lead to legalizing beekeeping in Los Angeles as evidenced by Los Angeles Councilmember Huizar's comments.

"When HoneyLove came to me two years ago, I was proud to lead the effort to legalize beekeeping. We are working to become a more sustainable City to confront the environmental crises of today, and bees, and beekeepers, are a part of the solution. It's time to support beekeeping in the City of Los Angeles' residential neighborhoods, which will help our bee population and make the City safer and greener."

We see the proposed partnership with the Los Angeles County Parks& Recreation as a natural fit with Honeylove's Mission and the Mission of the County's Nature Centers.

## HONEYLOVE COMMITMENT

Honeylove will support LACP&R programing at the Stoneview Nature Center as follows:

#### Nature Walks

Honeylove member George Braunegg will to prepare materials (laminated photos) and conduct training sessions (2 sessions are envisioned during the first quarter of 2020) to educate Stoneview Nature Center Staff on honeybees/pollinators to enable them to include the topic for discussion during Nature Walks. After the initial training George Braunegg will conduct additional training of new staff on an as needed basis.

George Braunegg will participate in two nature walks with members of the community and Stoneview Nature Center Staff during the first quarter of 2020 in connection with the training outlined above. Note: The timing of the walks must be mutually agreed upon at least 1 week in advance.

#### **Development of Educational Presentation Materials**

George Braunegg will prepare a 1 hour "Introduction to Honeybee / Urban Beekeeping PowerPoint presentation for use during group educational sessions in the facility's community room.

Conduct General Group Educational Sessions

George Braunegg will lead up to four 1 hour group sessions in 2020 for the community in Stoneview Nature Center community room.

# **Train Stoneview Nature Center Staff**

The expectation is that if Stoneview Nature Center Staff attend the four sessions referenced above, moving forward they could use the PowerPoint presentation on Honeybees / Urban beekeeping to conduct these group session talks themselves with or without George Braunegg in attendance. Of course George Braunegg would be available for questions and/or refresher training on an ongoing basis

## **Ongoing Educational Support Connected with Honeylove Meetings**

Honeylove will support Stoneview Nature Center by providing two types of ongoing educational programing linked to Honeylove meetings Stoneview Community Room and/or the Honeylove Apiary at Stoneview Nature Center:

- At least 6 times per year on the 4<sup>th</sup> Sunday in January, March, May, July, September, November
  - 1 hour Group Sessions/Classes on various Beekeeping topics. E.g Beekeeping 101, Rescuing Bees, Dealing with Cross Comb, etc.
  - 1.5 hour "Open Hive" Hands On Workshop/Class\* (15 person max)
    - Honeylove Members must sign a waiver prior to participation
    - Honeylove maintains an inventory of Adult and Children's beekeeping related protective clothing for use during these sessions that are made available to participants.
    - We anticipate that these Workshop/Class being on the same Sunday as the Group Session but we could expand both sessions and the number of participants depending upon the level of interest.
  - \* Note: Currently these Workshops/Classes are limited to HoneyLove Members only that pay a \$20 fee to attend. While we are willing to open these sessions at Stoneview Nature Center to Non-Members it is our expectation that we would continue to charge non-members the same fee as members.

#### **Honeybee Rescues**

Honeylove will provide Honeybee Rescues at the Stoneview Nature Center and the Kenneth Hahn State Recreation Area at NO COST, on a <u>Best Efforts</u> basis. "Best Efforts" is intended to communicate that Honeylove will use its access to Honeylove

members to secure beekeepers willing to conduct the rescue of swarms and colony's located on Park grounds. Honevlove will do its best to secure a beekeeper to conduct a rescue, based upon the physical challenges associated with the rescue and the county's timing needs/expectations. We trust the County can appreciate that Honeylove members do not make their living as beekeepers, they are volunteers that enthusiastically undertake honeybee rescues when they are available and capable of addressing the challenges presented by the physical location of the swarm or colony. However, depending upon the physical location of swarms or colonies and/or the County's time constraints or requirements. Honeylove may not be able to accommodate the County's needs in every situation. There could be situations where the County wants to have a swarm removed immediately (e.g. within 2 to 4 hours) given the swarm's proximity to public traffic, where despite Honeylove's "Best Efforts" to find a member willing to rescue the swarm, they cannot do so fast enough. Further, there could be situations where swarms or colonies are located in very hazardous places, e.g. very high in trees, on, in or near electrical poles, vents on steep roof-tops, etc. where Honeylove members may not be willing to venture to undertake the rescue. We want this relationship to be a long and successful one. Accordingly, we believe that it is important to be 100% transparent with regard our limitations with respect to Honeybee Rescues and don't want to set expectations with the County that we are not willing, or able, to commit to meeting or exceeding

# Populating and Maintaining the Honeylove Stoneview Apiary

HoneyLove will be responsible for populating and maintaining the bee hives located in the Apiary.

# **Single Point of contact**

On a day to day basis George Braunegg will be the primary Honeylove representative that may be contacted by LACDP&RR and/or Stoneview Nature Center Staff to address any and all issues related to the Proposed Honeylove Apiary at Stoneview Nature Center.

#### LACDP&R COMMITMENT

# Apiary

LACDP&R will provide HoneyLove a fenced in area for an Apiary on the grounds of the Stoneview Nature Center.

#### **Use of Community Room**

Use of a Stoneview Nature Center 1 Sunday a month to:

- Conduct a two hour Urban Beekeeping /Honeybee Educational meetings in the Community Room that will be open to HoneyLove members and citizens of Los Angeles County
- Conduct a two hour Mentoring Session for HoneyLove Members (Note: HoneyLove Members pay a \$20 fee to attend these hands on, open hive sessions. )

\* \* \* \* \*

Within 30 days of the provisional acceptance of this proposal Honeylove and LACP&R will mutual agree and document that agreement in writing related to the following issues:

- Apiary
  - $\circ$  Location
  - o Size,
  - Security
  - Physical structure
  - Water source
  - o Etc.
- Specific schedule of times when the colonies may be tended
- Stoneview Nature Center's needs/expectations relative to the maintenance of Apiary
- Timing of the removal of any or all beehives for whatever reason
- Ongoing evaluation of the relationship
- Protocol's for surfacing and resolving any concerns or issues

## ADDENDUM - 4/12/20

The following is an addendum the proposal issued by HoneyLove to the County of Los Angeles on 11/25/19. The purpose of this Addendum is to provide more clarity regarding the physical requirements and timing associated with the proposed establishment of a Honeybee Educational and Sanctuary Apiary. Based upon conversations with Stoneview Nature Center and Baldwin Hill Conservancy executives we are proposing two initiatives

## Honeybee Observation Hives in Stoneview Nature Center

Onsite Educational Observation Hives for the viewing pleasure of visitors and use by County personal during educational nature walks for up close observation (closed hive)

• Honeylove will install 1 to 3 honeybee colonies in traditional Langstroth Hives (approximately 25" x 20" at the base and 20 to 48 inches high) at a mutually agreed upon location (s) within the Center on moveable above ground stands.

Exhibit I attached shows other versions of the Langstroth Hives



• 1 of the 3 beehives on Stoneview property will be outfitted with at least 1 window for up close closed hive observation. Similar to the one illustrated in the photo below.

• To facilitate up close viewing during nature walks the outdoor observation hive will be modified to provide elevated Entry/Exit vs the traditional bottom Entry / Exit. This will ensure visitors will not impede forager activity and minimize interaction between observers and flying honeybees. (We believe that this was an approach used at Whitter Narrows when they had honeybees on Stoneview grounds.)



# Honeybee Sanctuary Apiary Adjacent to Stoneview Nature Center

Establish a Honeybee Apiary adjacent to Stoneview Nature Center to serve as a sanctuary where honeybee colonies rescued<sup>1</sup> from City, County and State Parks and the communities surrounding the Nature Center. In addition the Apiary would be used for the monthly, "Open Hive" introductory educational classes and mentoring sessions for local Urban/Backyard beekeepers as

documented in the original proposal.

Ideally the Apiary will consist of:

- Fenced 30 ft. x 30 ft. or 600 square feet of another configuration
  - The fence is to prevent theft and/or disturbance of the colonies.
  - We envision a fence like the one currently separating the oil field and County property
- Crushed gravel base over material to prevent weed growth and drainage
- A water source within 50 feet of the apiary (LA County requirement)
- Exhibit II contains two potential locations
- Location considerations
  - Observable from Stoneview Nature Center
  - Good water drainage
  - Access to a path to Stoneview Nature Center to facilitate
    - Open Hive Educational Classes
    - Installation of rescued colonies
    - Transportation of bee boxes during honey flow. Bee boxes filled with honey can weight 80 to 90 pounds each.
  - While not essential, it would be very helpful to have a small (approximately 5 ft x 10 ft) utility shed to store bee hives, beekeeping tools and equipment as well as a place to conduct activities such as Queen Grafting, honey extraction, queen marking and other typical beekeeping activities better conducted protected from the elements.
  - Privacy of Homeowners
    - HoneyLove is keenly aware of the need to ensure the privacy of residents living adjacent to Stoneview Nature Center.
    - Regardless of the location HoneyLove will work with the County to ensure that homeowner privacy is protected by a "Privacy Fence"
      - ~ In the short-term we propose the use of a privacy screen attached to the fence reference above that will surround the apiary.
      - As a long term solution we propose planting a California native vine, or other plant acceptable to County arborists, on the side of the fence not covered by the privacy screen. As the vine grows it will provide total privacy. Potential California native vines include:
        - ✓ California man-root, Marah fabacea
        - ✓ Pipestem, Clematis lasiantha
        - ✓ Southern California morning glory, Calystegia macrostegia

• Exhibit III illustrates the short and long term solutions proposed above.

Note: The vine covering the fence n Exhibit III is Ficus, pumila. While Ficus, pumila has characteristics that make it an exceptional candidate for such a fence it is not native to California.

Honeylove has discussed obtaining a grant from the Baldwin Hills Conservancy to cover the cost of implementing the above proposal. Upon the County's expression its willingness to seriously consider this proposal HoneyLove will immediately begin determining the County's requirements and in turn establish a cost estimates in order to write a grant proposal to the Baldwin Hills Conservancy.

# PROPOSED IMPLEMENTATION PLAN

Honeylove proposes the implementation of this proposal in two phases.

#### Phase I - Spring/Summer 2020

Install Honeybee Observation Hives in Stoneview Nature Center

*Note:* Honeylove would also will use this time to develop the Grant request referenced above

#### Phase II - Fall 2020 (After completion of the bridge)/Winter 2021

Establish the Honeybee Sanctuary Apiary Adjacent to Stoneview Nature Center



**Background:** California Conservation Corps Foundation (CCCF) has requested and was granted a second amendment to contract #BHC 1800 for the Water Capture Project at Yvonne B. Burke Sports Complex pursuant to the Executive Officer's delegation authority under Res #16-06. The CCCF request (See Attachment 1: Amendment Request Letter) included an extension of the Performance Period through October 2022, as well as approval of line-item shifts within the Project Budget (See Attachment 2: Schedule & Budget). The revised twenty-two-month schedule allows sufficient time for project completion, approval and close out. Both the changes to the budget and schedule were due to the evolution of the project design based on site constraints and opportunities discovered during the geotechnical analysis process. These adjustments do not increase project costs or overall implementation outcomes.

The project history dates back to May 2018 when the Governing Board approved Resolution #18-02, which authorized a Grant of BHC Proposition 1 Funds, in the amount of \$1,500,000 to the California Conservation Corps Foundation (CCCF) for the Stormwater Management Project at the Yvonne Brathwaite Burke Sports Complex.

During 2019, CCCF worked to secure a credit line for subcontracts, bid and executed sub-agreements, as well as conducted onsite geological investigations. In May of 2019, CCCF requested and was granted a 10-month extension to the Performance Period for agreement #BHC1800.

The Project purpose is to address the need to manage site runoff, reduce erosion, stabilize the slope, and create opportunities for captured stormwater to recharge the local groundwater basin. The Project is designed to retain peak flows using natural treatment systems to reduce dry-weather, stormwater, and irrigation runoff including total suspended solids, thus improving the quality of water flowing into the Ballona Creek. The project will enhance the park and include new interpretive features.

Milestones currently achieved to date include:

- Geotechnical Investigation Analysis and Report
- Landscaping Design Plan Profile Drawings (See Attachment 3: Preliminary Design)
- Base Mapping & Report
- Executed construction contract



#### ASSEMBLY BILL

No. 963

#### Introduced by Assembly Member Kamlager

February 17, 2021

An act to amend Sections 32550, 32551, 32553, 32555, 32556, 32565, 32565.5, 32567, 32568, 32571, 32573, 32574, and 32575 of, to amend the heading of Division 22.7 (commencing with Section 32550) of, to add Section 32573.1 to, and to repeal Section 32580 of, the Public Resources Code, relating to conservancies.

#### LEGISLATIVE COUNSEL'S DIGEST

AB 963, as introduced, Kamlager. Baldwin Hills Conservancy: urban watersheds conservancy expansion.

(1) The Baldwin Hills Conservancy Act establishes, until January 1, 2026, in the Natural Resources Agency, the Baldwin Hills Conservancy, created with the purpose, among other purposes, to acquire and manage public lands within the Baldwin Hills area, as defined.

This bill would expand the area covered by the conservancy to include the southern Ballona Creek Watershed, as defined, and the Upper Dominguez Channel, as defined. The bill would rename the conservancy the Baldwin Hills and Urban Watersheds Conservancy and make conforming changes.

The bill would repeal the January 1, 2026, sunset date, thereby extending the act indefinitely.

(2) The act requires the conservancy's governing board to consist of 13 voting members, including one member from the Los Angeles County Board of Supervisors within whose district the majority of the Baldwin Hills area is located. The act requires 6 of these members to be appointed by the Governor with 4 out of that 6 to be residents of specified areas.

This bill would delete the above provisions relating to those members and expand the voting membership of the conservancy's board to consist of 15 voting members by including the mayors of the Cities of Los Angeles and Culver City, an appointee from the South Bay Cities Council of Governments, and a member of the Los Angeles County Board of Supervisors representing District 2. The bill would require the Governor to appoint 5 of the voting members, who are nominated by a city council or a neighborhood empowerment group, as provided.

The act requires the conservancy's board to also consist of 7 nonvoting members.

This bill would expand the nonvoting membership of the conservancy's board to consist of 12 nonvoting members by including the Director of the Los Angeles County Department of Public Works, among others, as provided.

(3) The act requires the conservancy to do certain things, including develop and coordinate an integrated program of resource stewardship so that the entire area is managed for optimum recreational and natural resource values, as provided.

This bill would also require the entire area to be managed for optimum climate resilience.

The act also requires the conservancy, as part of its duties, to approve conservancy funded projects, enter into a memorandum of understanding with the Department of Parks and Recreation, and approve specified master plans, among other things, as provided.

This bill would delete these duties and would instead require the conservancy to carry out projects and activities to further the purposes of the act, study the potential environmental and recreational uses of the Baldwin Hills, southern Ballona Creek Watershed, and Upper Dominguez Channel area, and develop and adopt a proposed watershed and open-space plan for improvements in the conservancy territory, as provided. The bill would require a report on this plan to be provided to the Legislature on or before January 1, 2023.

(4) The act requires the conservancy to administer any funds appropriated to it and any revenue generated by public agencies for the Baldwin Hills area and contributed to the conservancy, and authorizes the conservancy to expend those funds for capital improvements, land acquisition, or support of the conservancy's operations.

This bill would require the conservancy to additionally administer any funds appropriated to it for these purposes from any future bond act or local initiative measure, as provided.

(5) In addition, this bill would establish the Baldwin Hills, Southern Ballona Creek Watershed, and Upper Dominguez Channel Urban Watershed Improvement Program, to be administered by the conservancy, for climate change adaptation improvements, to protect, conserve, and restore the health and resilience of the watersheds and communities of the region, as provided.
