10:00 a.m. Call to Order - A public meeting of the Baldwin Hills Conservancy (BHC) was assembled at 10:05 a.m. on Friday, June 03, 2022, via a hybrid format.

I. Roll Call – David McNeil, BHC Staff

Members Present: Armando Abrego, Alina Bokde, Colin Conner, Megan Cooper, Jaqueline Dupont-Walker, Yolanda Gorman, Robert Jones, Dr. Nicole Lawson, Sally Lukenbill, Colin Conner (for Jennifer Lucchesi), Amanda Martin, Udak-Joe Ntuk, Craig Sap, Keshia Sexton.

Staff Present: David McNeill, Executive Officer; Gail Krippner, Grant Program Manager; Tiffany Jones, Project Manager; Lena Sheet, Deputy Attorney General.

II. Presentation on Department of Conservation's California Working and Natural Lands Framework – Elizabeth Betancourt, Natural and Working Lands Advisor, Department of Conservation

Ms. Betancourt gave a PowerPoint overview of the new direction for the Department of Conservation. While traditionally the divisions focused on their respective responsibilities, the new framework seeks to connect and unify the different divisions. All four divisions, including the California Geological Survey, the Division of Land Resources Protection, the Division of Mine Reclamation, and the Geologic Energy Management Division will all focus on four themes of natural and working lands. This new effort will allow the DOC to use its collective expertise to address the challenges and opportunities in California.

Chair Cooper asked how the Department of Conservation is involved in the 30X30. Ms. Betancourt responded that the DOC was an integral part of the development. They have a GIS specialist that provides a lot of the mapping. In terms of implementation, meeting with the various conservancies and other state departments serves to meet part of those goals. Ms. Betancourt also is part of an advisory panel that will create and measure the success of the goals via a dashboard.

Chair Cooper asked if this regulatory, funding, or technical assistance. Both Ms. Betancourt and Member Joe-Ntuk explained that this would fall mostly under CALGem, as CGS is more administrative. Executive

Officer McNeill followed up with a question regarding funding and how they will be distributed. Ms. Betancourt responded it is dependent on the program and the grant process.

III. Approval of Minutes (June)- Megan Cooper, Chair

Member Gorman provided a motion to approve the minutes unanimously. Member Jones seconded the motion. There being no objections or questions, the Chair called for any objections to the approval of the minutes. With no objections, the minutes were approved.

IV. Public Comments – Megan Cooper, Chair

There were no public comments.

V. Consideration of a Resolution authorizing a Grant of BHC Wildfire Prevention Funds, in an amount not to exceed \$311,000, to the California Conservation Corps – David McNeill, Executive Officer

Executive Officer McNeill introduced two members of the California Conservation Corps that attended. He then discussed that phase 1 of the project is proposed to start in the summer of 2022. It will focus on right of ways, trails and external wildland urban interface. Phase 2 of the project includes the creation of defensible fuel mitigation space for internal structures that will address developed areas of the parklands.

Chair Cooper asks Conservation Corps representatives and McNeill about the partnership between the BHC and the county. McNeill replied that this project is a one-time opportunity to clear wildfire fuel from areas that are not covered by the county's annual clearing. It will reduce the risk on trails and behind local houses. Member Bokde remarked that this is a good use of the funding, and it would be great leverage the partnership with the county. She remarked her department has ongoing weed maintenance agreements with all the different Conservation Corps.

Member Lawson asked if this would affect park users through road or trail closures. Conservation Corps representatives and McNeill replied that if there are any closures, they will keep the public informed.

Member Lawson provided a motion. Member Dupont-Walker seconded the motion. Executive Director McNeill conducted a roll call vote. With a vote of all ayes and with no nays, the motion passed.

VI. Executive Officer Report: Legislative, Operations, Project Status, and Fiscal updates – BHC Staff Representatives

Executive Director McNeill started the report by asking board members and members of the public to conserve water. He discussed the incentives of changing to drought tolerant front yards and limiting water usage. He also discussed he will be in Sacramento for the new Natural Resources building opening and all Directors meeting.

Project status updates were given by staff member Gail Krippner. Staff member Jones reported on the status of the HoneyLove apiary at Stoneview Nature Center. Krippner talked about the need to amend the DTSC project for Environmental Oversight. The Los Angeles County Department of Parks and Recreation Green Valley Connection Improvement project is currently developing a scope of work for the California Conservation Corps. The project's expected completion date is March of 2026. KDI is

continuing its community advisory meetings to reach out and help bridge the gap between conservation and the local community. Tree People's grant for the Baldwin hills Reservoir Revitalization and Restoration plan is conducting outreach through community events and meetings. The outreach schedule was finalized, and the first meeting was held at the end of last February. The project's completion is expected in December 2022. Climate Resolve's Community Resilience and Access plan met with the county park planners to discuss conceptual plans for KHSRA. The project completion is expected in October 2022. McNeill added that there are a lot of extensions on grant projects due to pandemic related delays over the past 12 months.

Executive Officer McNeill shared that the reintroduction of the conservancy expansion bill, SB1052, passed from the Senate Floor and was heading to the Assembly for committee hearings. This bill would increase the conservancy's territory by 20 times its current size. He also discussed the hiring of 2 new office personnel.

Member Lawson discussed the opening of the new metro rail system and how will open the area to more access for people in the community.

<u>Recommendation</u>: No action required. The linked <u>PowerPoint presentation</u> will be shown at the meeting.

Background: Climate Resolve is nearing completion of the <u>Resilience and Access Plan</u> for the Baldwin Hills. The final stage is to present the summarized outreach efforts, community feedback and draft recommendations for review and input prior to publishing. The need to introduce climate resilience infrastructure elements into the Baldwin Hills Parklands comes at a critical time. The recommended series of interventions will help this regional South LA public space adapt to severe weather, drought and other environmental emergencies.

According to recent reports, Researchers at UCLA's Fielding School of Public Health have released a new tool showing which communities throughout the state are hit hardest by extreme heat caused by the climate crisis. Using <u>maps</u>, the project shows the increase in visits to local emergency rooms on so-called "extreme heat days" as compared to visits on other days.

In Los Angeles County, the areas reported most affected by extreme heat days include the northern and western San Fernando Valley, Northeast L.A. and Highland Park, **South L.A.**, Wilmington and San Pedro, East L.A. and Baldwin Park, Valinda, Pomona, and western Lancaster.

Last month, another <u>study</u>, an analysis of United States municipal plans released by UCLA researchers found that most large American cities are not prepared to combat heat-related problems. Among the 50 municipalities studied, including L.A., 78% mentioned heat in their climate plans, but few include strategies to address it.

Legislative Update

SB1052 Kamlager-Dove: On June 29th, the <u>Baldwin Hills Conservancy: Urban</u> <u>Watersheds Conservancy Expansion bill</u> was placed in the suspension at the Assembly Appropriations Committee. The bill will likely be addressed when the committee returns from recess after August 3rd.

Compton Unified School District Students will be meeting in the Baldwin Hills Parklands on August 3rd as part of their Environmental Justice Residency Grant supported by University of California Irvine's Education Department. The field trip will bring 100 students to learn about the nexus between the public policy, community advocacy, open space, public health and environmental justice in a region that is home to the largest urban oil field in the country. The BHC and Natural Resources Defense Fund are among the guest speakers for the day long visit.
